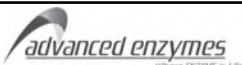

ठाणे, दि. १९ – ठाणे शहरात पावसाळ्या पूर्वीची नालेसफाई हा दरवर्षी चर्चेचा विषय असतो. मागील वर्षी मुसळधार पावसाने शहरात नाले परिसरात पूरव्य परिसि्थी ओढावली होती. यंदादेखील शक्यता आहे त्याची पुनरावृत्ती होण्याची शक्यता वर्तवण्यात येत आहे. लॉकडाऊन असताना आवश्यक बाब म्हणून शहरात नाले सफाईला परवानगी देण्यात आली होती. मात्र ती केवळ कागदावरच झाल्याचे चित्र दिसून येत आहे.

पावसाने गुरवार पासुन दमदार सुस्वात केली असून आता शहरातील नाल्यांच्या साफसफाईची प्रश्न पुन्हा ऐरणीवर आला आहे. ठाणे महापालिकेच्या वतीने शहरातील नालेसफाई ९५ टक्के पूर्ण करण्यात आल्याचा दावा प्रशासनाच्या वतीने करण्यात येत असला तरी शहरातील नाल्यांची सफाई म्हणावी तशी पूर्ण झालेली नसल्याचं प्रत्यक्ष पाहणीतून स्पष्ट झालं आहे. अनेक नाल्यांमध्ये सफाई अर्धवट झालेली असून काही ठिकाणी नाल्यातील गाळ काढून नाल्याच्या किनारी ठेवण्यात आलेला आहे. त्यामुळे पावसाच्या पाण्याने तो पुन्हा नाल्यात जाण्याची दाट शक्यता आहे.
